My dear Sir:-

On January 25, 1919, Lieutenant Colonel Edward H. Williams (Office of Procurement Section) was good enough to give me certain information in regard to my letter of the 3rd of the same month. If you will be good enough to have reference made to that correspondence you will find that there were returned to me two letters from Senator Knox, one from Mr. Carr and one from Major Clark bearing upon my application for appointment under the Judge Advocate General's Department; and that your last letter stated that no information had been found regarding the letters from Honorable A.A. Adee and from Mr. W.A. Smythe.

As to this last statement by your office I beg to say that the missing letters were filed in connection with my other application made to General M. Churchill when I was subsequently seeking a commission under the Department of Military Intelligence.

I particularly request that you be so kind as to have another search made in order that there may be returned to me as fully as possible, all papers filed in connection with my repeated efforts to gain a commission.

I shall be glad if you will kindly have the reply mailed me in care of Senator Knox, and
