## STATEMENT OF PURPOSE

We are for immediate, unrelenting and unceasing war to the finish upon Hitler. As the first step, we advocate all possible use of our naval and air forces to clear the Atlantic everywhere of the Axis offensive against Allied and neutral shipping. We advocate the seizure of all islands and strategic points—in any ocean—necessary to insure our defense, and we urge the use of our military forces to hold and occupy those points. We maintain that the Neutrality Law is suicidal to our self-defense, and that Congress should repeal it now, in order to re-establish freedom of the seas—Hitler has already demonstrated that he is ready to torpedo United States shipping outside that zone.

We advocate these measures, and all other militant, aggressive steps dictated by common sense, honesty and decency.
